RESOLUTION OF THE AUTHORIZING THE SALE OF SURPLUS PERSONAL
PROPERTY NO LONGER NEEDED FOR PUBLIC USE THROUGH GOVDEALS.COM
PUBLIC ONLINE AUCTION

WHEREAS, the Township of Franklin has determined that the personal property described on Schedule A attached hereto and incorporated herein is no longer needed for public use; and

WHEREAS, the Township of Franklin intends to utilize the online auction services of GovDeals public online auction, pursuant to Sourcewell Cooperative Purchasing Online Surplus Auctions & Payment Processing Contract #012821-GDI, at GovDeals.com (The terms and conditions of the agreement entered into with GovDeals is available online at www.govdeals.com); and

WHEREAS, the sales are being conducted pursuant to N.J.S.A. 40A:11-36 and the guidance set forth in the Division of Local Government Services' Local Finance Notice 2019-15,

THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Franklin in the County of Gloucester State of New Jersey, authorize the sale of Township property no longer needed for public use and that the public auction shall be conducted through GovDeals.com public online auction pursuant to NJSA 40A:11-36 and Local Government Services; and Sourcewell Cooperative Purchasing Online Surplus Auctions & Payment Processing Contract #012821-GDA; and

BE IT FURTHER RESOLVED, that the sale of surplus property to be sold in "as is" condition without expressed or implied warranties (See Schedule A); and

BE IT FURTHER RESOLVED, that the Township of Franklin reserves the right to accept or reject any bid submitted; and

BE IT FURTHER RESOLVED, that the successful bidder(s) shall be required to pay the full amount of the sale, execute a Hold Harmless and Indemnification Agreement concerning use of said surplus property, and shall be required to plan for the pick-up of sold property from the Township of Franklin within 10 business days of the auction; and

BE IT FURTHER RESOLVED, the Township Clerk shall publish a legal advertisement in the official newspaper informing the public as to the scheduled dates of the online public auction, the nature of items being sold, and how to obtain more information on the sale as required by NJSA 40A:11-36; and

BE IT FURTHER RESOLVED, that all other township officials and employees are hereby authorized and directed to take all action necessary and appropriate to effectuate the terms of this Resolution.
