

ADDENDUM TO
INTERLOCAL AGREEMENT BETWEEN
THE TOWNSHIP OF FRANKLIN, GLOUCESTER COUNTY, NEW JERSEY,
AND
THE BOROUGH OF NEWFIELD, GLOUCESTER COUNTY, NEW JERSEY

The undersigned parties agree to amend the Interlocal Agreement dated November 1, 2017, through November 1, 2022, between the Township of Franklin (“Township”) and the Borough of Newfield (“Borough”) for the provision of Police Services, as follows:

1. Paragraph 1(a) - Contract Term (Term of Agreement).
The term during law enforcement services will be provided by the Township to the Borough shall continue for one hundred and twenty-two (122) months, commencing on November 1, 2022, and ending on December 31, 2032.
2. Paragraph 2(b) – Services.
The Township may utilize the Newfield Police facility, if available, for police operations, the Detective Bureau and a sub-station for the officer(s) on duty on an as-needed basis as determined by the Township of Franklin.
3. Paragraph 4 – Payment and Obligations of the Borough of Newfield – Exhibit “A” (incorrectly identified in the Agreement as Exhibit B).
