**NOW, THEREFORE, BE IT RESOLVED**, that the Tax Collector be and is hereby authorized to issue duplicate certificates to be marked "Duplicate Certificate" as required by law, to said purchaser covering the certificates lost as previously described all in accordance with the requirements of Chapter 99 of Public Laws of 1997.

**AND BE IT FURTHER RESOLVED** that a properly executed copy of this Resolution and the Loss Affidavit be forwarded to the Tax Collector and Chief Financial Officer for the records.
