

**RESOLUTION
TOWNSHIP OF FRANKLIN
RESOLUTION AUTHORIZING THE TAX COLLECTOR AND TREASURER TO
REFUND OVERPAYMENT OF REAL ESTATE TAXES PAID FOR THE 2013
TAX YEAR AND TO CANCEL ANY FUTURE TAX BILLINGS FOR THE
PREMISES LOCATED AT BLOCK 5078, LOT 23 ON THE TAX MAPS OF THE
TOWNSHIP OF FRANKLIN

WHEREAS, the Township Committee of the Township of Franklin, County of Gloucester, State of New Jersey is in receipt of a request from the Municipal Tax Collector and Assessor for a resolution authorizing a real estate tax refund for property denoted on the Township of Franklin tax maps as Block 5078, Lot 23, being commonly known as 1970 West Blvd., Malaga, New Jersey 08328; and

WHEREAS, the owner of said property, Freddie and Lucy Campbell, have paid taxes in 2013 in the amount of \$892.21 (\$37.96 in February and \$854.25 in May); and

WHEREAS, the owner of the aforementioned property, Freddie Campbell, is qualified as a totally disabled veteran as of April 23, 2013 and is therefore tax exempt creating overpayments as set forth above; and

WHEREAS, the Township Committee of the Township of Franklin, County of Gloucester, State of New Jersey, after due deliberation has determined that it is appropriate to refund the overpayment of taxes above stated and to cancel all future taxes on said property in light of the owner's status as a totally disabled veteran;

NOW, THEREFORE, BE IT RESOLVED, by the Township Committee of the Township of Franklin, County of Gloucester, State of New Jersey that a refund in the amount of \$892.21 (\$37.96 paid in February and \$854.25 paid in May) respecting the property known as Block 5078, Lot 23, shall be refunded and shall be payable to Freddie Campbell, 1970 West Blvd., Mantua, New Jersey 08328; and

BE IT FURTHER RESOLVED, that in accordance with the determination of 100% permanent and total service connected wartime disability (N.J.S.A. 54:4-3.30) by the United States Department of Veteran's Affairs, all future tax billing for the year 2013 as well as all future tax billing shall be cancelled and be further exempt from taxation; and

BE IT FURTHER RESOLVED, that a properly executed copy of this resolution shall be forwarded to the Tax Collector, Tax Assessor and Treasurer for their records.
