FOR BLOCK 301 LOT 8.05.**

**WHEREAS**, the Township Committee of the Township of Franklin, County of Gloucester, State of New Jersey is in receipt of a request from the Municipal Tax Collector of the Township of Franklin for a Resolution authorizing a refund to the property owner of an overpayment of 2013 Property Taxes due to a duplicate tax payment from Champion Title & Settlement Services, Inc.; and

**WHEREAS**, David Schultz and Monica Attanasi are the owners of record of Block 301, Lot 8.05 on the Tax Map of the Township of Franklin, also known as 164 Ashley Drive; and

**WHEREAS**, in the 2013 Tax Year, this property received a payment from Champion Title & Settlement Services, Inc. on June 28, 2013 in the amount of \$ 3,142.30 and on again June 28, 2013 received a wire payment of \$ 3,142.30 in a bulk payment from Bank of America; and

**WHEREAS**, the Tax Collector of the Township of Franklin is in receipt of a request by Champion Title & Settlement Services, Inc., for a refund of the Overpayment of \$ 3,142.30 to be refunded to the property owners for Block 6501, Lot 24; and

**WHEREAS**, after due deliberation and discussion with the Township Administrator, Treasurer, and Tax Collector, the Township Committee of the Township of Franklin, County of Gloucester has determined that it is appropriate for the Township of Franklin to refund the overpayment payment of taxes to David Schultz and Monica Attanasi.

**NOW, THEREFORE, BE IT RESOLVED**, by the Township Committee of the Township of Franklin, County of Gloucester, State of New Jersey, that the Overpayment of real property taxes in the amount of \$ 3,142.30, shall be refunded to David Schultz and Monica Attanasi, 164 Ashley Drive, Franklinville, NJ 08322; and

**BE IT FURTHER RESOLVED**, that a copy of this Resolution be forwarded to the Tax Collector and Treasurer of the Township of Franklin for their records.
