

**TOWNSHIP OF FRANKLIN  
RESOLUTION AUTHORIZING THE TAX COLLECTOR  
AND TREASURER TO REFUND \$ 2,670.46 OVERPAYMENT  
RESULTING FROM A REDUCTION IN ASSESSMENT  
FROM THE 2013 GLOUCESTER COUNTY PROPERTY REVALUATION.  
FOR BLOCK 1001 LOT 56.**

**WHEREAS**, the Township Committee of the Township of Franklin, County of Gloucester, State of New Jersey is in receipt of a request from the Municipal Tax Collector of the Township of Franklin for a Resolution authorizing a refund to the property owner of an overpayment of 2013 Property Taxes due to a reduction in Tax Assessment due to the Gloucester County 2013 Revaluation.; and

**WHEREAS**, Kim A. and Diane E. Miller are the owners of record of Block 1001, Lot 56 on the Tax Map of the Township of Franklin, also known as 3560 Coles Mill Road; and

**WHEREAS**, in the 2013 Tax Year, this property received a new Property Tax Assessment from the Revaluation that was performed by Gloucester County; and

**WHEREAS**, the Tax Collector of the Township of Franklin is in receipt of a request by Diane E. Miller, for a refund of the Overpayment due to the Overbilling of \$ 2,670.46 to be refunded to the property owners for Block 1001, Lot 56; and

**WHEREAS**, after due deliberation and discussion with the Township Administrator, Treasurer, and Tax Collector, the Township Committee of the Township of Franklin, County of Gloucester has determined that it is appropriate for the Township of Franklin to refund the overpayment payment of taxes to Kim A. and Diane E. Miller.

**NOW, THEREFORE, BE IT RESOLVED**, by the Township Committee of the Township of Franklin, County of Gloucester, State of New Jersey, that the Overpayment of real property taxes in the amount of \$ 2,670.46, shall be refunded to Kim A. and Diane E. Miller, 3560 Coles Mill Road, Franklinville, NJ 08322; and

**BE IT FURTHER RESOLVED**, that a copy of this Resolution be forwarded to the Tax Collector and Treasurer of the Township of Franklin for their records.
