

**RESOLUTION
TOWNSHIP OF FRANKLIN
RESOLUTION AUTHORIZING THE TAX COLLECTOR AND TREASURER TO
REFUND OVERPAYMENT OF REAL ESTATE TAXES PAID FOR THE 2013
TAX YEAR AND TO CANCEL ANY FUTURE TAX BILLINGS FOR THE
PREMISES LOCATED AT BLOCK 5702, LOT 50.03, BEGIN COMMONLY
KNOWN AS 2747 MAIN ROAD ON THE TAX MAPS OF THE
TOWNSHIP OF FRANKLIN
R-153-13**

WHEREAS, the Township Committee of the Township of Franklin, County of Gloucester, State of New Jersey is in receipt of a request from the Municipal Tax Collector and County Assessor for a Resolution authorizing a real estate tax refund for the property denoted on the Township of Franklin tax maps as Block 5702, Lot 50.03, commonly known as 2747 Main Road; and

WHEREAS, the owner of said property, Robert Johnson, has paid taxes in August 2013 in the amount of \$467.70 and has been billed for taxes but has not yet paid the amount of \$1,405.46 for November 2013, \$1,464.37 for February 2014 and \$1,464.37 for May 2014; and

WHEREAS, the County Assessor has forwarded to the Township of Franklin information identifying the aforementioned property owner as a qualified and totally wartime connected disabled veteran as of August 29, 2013; and

WHEREAS, the owner of the aforementioned property is qualified and is therefore tax exempt creating an overpayment in the amount of \$467.70 as set forth above; and

WHEREAS, the Township Committee of the Township of Franklin, County of Gloucester, State of New Jersey, after due deliberation has determined that it is appropriate to refund the overpayment of taxes above stated and to cancel all future taxes on said property in light of the owner's status as a totally disabled veteran;

NOW, THEREFORE, BE IT RESOLVED, by the Township Committee of the Township of Franklin, County of Gloucester, State of New Jersey that a refund of \$467.70 (the sum of taxes paid since the determination of disability) respecting the property known as Block 5702, Lot 50.03 shall be refunded and shall be payable to Robert Johnson, 2747 Main Road, Franklinville, New Jersey 08322; and

BE IT FURTHER RESOLVED, that in accordance with the determination of 100% permanent and total service connected wartime disability (N.J.S.A. 54:4-3.30) by the United States Department of Veteran's Affairs, all future tax billings for the year 2013 and 2014 shall be cancelled and shall be further exempt from taxation; and

BE IT FURTHER RESOLVED, that a properly executed copy of this resolution shall be forwarded to the Tax Collector, County Tax Assessor and Treasurer for their records.
