**RESOLUTION APPOINTING CONFLICT PROSECUTOR FOR THE TOWNSHIP OF FRANKLIN JOINT MUNICIPAL COURT FOR THE YEAR 2024, PURSUANT TO LOCAL PUBLIC CONTRACTS LAW (N.J.S.A. 40A:11-1, ET SEQ.) AND IN ACCORDANCE WITH PUBLIC LAW 1996, c. 95, SECTION 14 (N.J.S.A. 2B 12-1, ET AL.)**

**WHEREAS**, there exists a need for Conflict Prosecutors in the Township of Franklin for the Franklin Joint Township Municipal Court; and

**WHEREAS**, pursuant to the provisions of N.J.S.A. 19:44A-20.5, the Township Committee has determined to award said contract as a fair and open contract; and

**WHEREAS**, the CFO has certified the availability of funds in an amount not to exceed \$10,000 per year at a rate of \$500.00 per full day session and \$300.00 per half day session, which shall be charged against budget line items #4-01-25-275-028 entitled Prosecutor-Professional Services.

**WHEREAS**, the Local Public Contracts Law (N.J.S.A. 40A:11-1 et seq.) requires the governing body of a contracting unit to publish a notice in a newspaper authorized by law to publish its legal advertisements, setting forth the nature, duration, service and amount of the contract where such contract is awarded for "professional services".

**NOW THEREFORE, BE IT RESOLVED**, by the Township Committee of the Township of Franklin, County of Gloucester, State of New Jersey, as follows:

1. Amanda Mazzoni, 1170 East Landis Avenue, Vineland NJ 08360 is appointed as Conflict Prosecutor and any licensed practicing lawyer in the State of NJ who in any other municipality in the County of Gloucester, State of NJ is hereby retained as Conflict Prosecutors for the Township of Franklin for the year 2024 in accordance with Public Law 1996, c. 95 Section 14 (N.J.S.A. 2B 12-1, et al.) provided they execute the attached agreement.

2. The appropriate officers of the Township of Franklin are hereby authorized to enter into the contract with, for the legal services above specified, for a one (1) year term commencing January 1, 2024, and to be paid in accordance with the 2024 Budget.

3. The contract is awarded as a "professional service" under the provision of the Local Public Contracts Law because of the specialized training, education, experience and specialized knowledge needed for this position and pursuant to a "fair and open" process as provided in N.J.S.A. 19:44A-20.4 et seq.

4. A notice of the award of this contract shall forthwith be printed once in The Sentinel, an official newspaper of the Township of Franklin, authorized by law to publish the legal advertisements of the Township Committee of the Township of Franklin, setting forth the nature, duration, service and amount of the contract, and further stating that this resolution and the annexed contract are on file and available for public inspection in the Office of the Clerk of the Township of Franklin.

**AGREEMENT**

**WHEREAS**, the Township of Franklin, hereinafter referred to as "Township", requires the services of a Conflict Prosecutor for the calendar year 2024, commencing January 1, 2024; and

**WHEREAS**, hereinafter referred to as "Township Conflict Prosecutor", is a licensed attorney in the State of New Jersey, has agreed to accept the appointment of the Township for the performance of the duties of attorney subject to the following terms and conditions:

**WITNESSETH:**

1. The Township Conflict Prosecutor shall be appointed to a one (1) year term to represent the Township for the calendar year 2024, commencing January 1, 2024, and he shall perform all duties required of a local representative of the Township.

2. During the term of this Agreement, the Township Conflict Prosecutor shall devote his/her best efforts to advance the interest of the Township; he shall perform his/her duties to the best of his/her ability and in accordance with the Code of Professional Ethics by the New Jersey Supreme Court and in accordance with Public Law 1996, c. 93, Section 14 (N.J.S.A. 2B 12-1 et al.)

3. The Township Conflict Prosecutor shall receive \$500.00 per full day session and \$300.00 per half day session.
