RESOLUTION AUTHORIZING A PURCHASE OF ONE (1) 2024 PETERBILT 520 WITH HEIL AUTOMATED DURAPACK PYTHON 32 CUBIC YARD EJECT AND DUMP HOPPER VIA SOURCEWELL CO-OP #091219-THC (HEIL) FROM MID-ATLANTIC WASTE SYSTEMS, EASTON, MD

WHEREAS, the Township desires to purchase one (1) 2024 Peterbilt 520 with Heil automated durapack python 32 cubic yard eject and dump hopper for the Franklin Township Department of Public Works;

WHEREAS, Mid-Atlantic Waste Systems, Easton, MD has a NJ state recognized Sourcewell purchasing co-op, via a public bidding process with a member number of #19463;

WHEREAS, Mid-Atlantic Waste Systems has one (1) 2024 Peterbilt 520 with Heil automated durapack python 32 cubic yard eject and dump hopper available for purchase under above Sourcewell co-op in the amount of \$390,058.80 for the vehicle as stated under quote #:RSST1503;

WHEREAS, the CFO has certified the availability of funds for and amount of \$184,708.80 under the previously approved Capital purchase resolution from account #C-04-23-012-001 and the remaining amount of \$205,350.00 from insurance claims reimbursement and account #4-01-55-100-100;

NOW THEREFORE BE IT RESOLVED, by the Mayor and Committee of the Township of Franklin, County of Gloucester, State of New Jersey as follows; the CFO is authorized to complete the financial transactions associated with purchasing the above identified 2024 Peterbilt 520 with Heil automated durapack python 32 cubic yard eject and dump hopper for the Franklin Township Department of Public Works, in the amount of \$390,058.80 for the vehicle.

BE IT FURTHER RESOLVED that the Mayor and the Administrator are authorized to execute all documents required to effectuate this contract.
