A Circulator/Witness may circulate one or more petitions and one or more petitions may be filed on behalf of candidate(s) providing:

1. All petitions are filed on or before 4:00 p.m. on the 71st day preceding the day of Primary Election.
2. The aggregate number of valid signers of the petition(s) must equal or exceed the number required by law.
3. The signers are qualified voters and reside in the political subdivision for which the candidate stands for office.
4. The candidate(s) endorsed in the petition fully complete and execute one or more petitions with respect to Section E. Certificate of Acceptance and Section F. Oath/Affirmation/Declaration of Allegiance (19:23-7).
