**RESOLUTION AUTHORIZING ACCEPTANCE AND DELIVERY OF (1) 2024
PETERBILT 567 WITH GALBREATH ROLL OFF HOIST VIA SOURCEWELL CO-
OP #041217-WQI FROM MID-ATLANTIC WASTE SYSTEMS, EASTON, MD**

WHEREAS, the Township had desired to purchase one (1) 2023 Peterbilt 567 with Galbreath roll-off hoist for the Franklin Township Department of Public Works, which was authorized under R-234-23;

WHEREAS, Mid-Atlantic Waste Systems, Easton, MD has a NJ state recognized Sourcewell purchasing co-op, via a public bidding process for the same with a Wasteq co-op member number of #199939, under quote#: RSSQ39814-A;

WHEREAS, Mid-Atlantic Waste Systems has requested a change and upgrade to vehicle being delivered at no additional costs to Franklin Township. They will be delivering one (1) 2024 Peterbilt 567 with Galbreath U75-OR-174 75,000 pound roll-off hoist for purchase under above Sourcewell co-op in the amount of \$264,970.50 for the vehicle as stated under attached quote #:RSSQ40518;

WHEREAS, the CFO has previously certified the availability of funds for under the previously approved Capital purchase resolution from account #C-04-23-012-002;

NOW THEREFORE BE IT RESOLVED, by the Mayor and Committee of the Township of Franklin, County of Gloucester, State of New Jersey as follows; the CFO is authorized to complete the financial transactions associated with the delivery of the above identified 2024 Peterbilt 567 with Galbreath roll-off hoist for the Franklin Township Department of Public Works, in the amount of \$264,970.50 for the vehicle.

BE IT FURTHER RESOLVED that the Mayor and the Administrator are authorized to execute all documents required to effectuate this contract.
