**WHEREAS**, the Township desires to purchase a new 2024 International CV515 SFA Truck for use by the Department of Public Works under the attached specifications;

**WHEREAS**, Allegiance Trucks 525 West Linden Avenue, Linden, NJ 07036 has a NJ state recognized Sourcewell purchasing co-op, via a public bidding process for the same with a co-op member number of #060920-NVS;

**WHEREAS**, Said truck will be purchased under above Sourcewell co-op in the amount of \$126,796.00 stated under quote #:12456-01;

**WHEREAS**, the CFO has certified the availability of funds from the following account #G-02-47-000-004; Clean Communities Grant (in amount of \$49,847.50); #G-02-09-500-001; Recycling Grant Monies (in amount of \$64,135.39) and #C-04-23-012-001; Capital Expenditure Purchase (in amount of \$12,813.11).

**NOW THEREFORE BE IT RESOLVED**, by the Mayor and Committee of the Township of Franklin, County of Gloucester, State of New Jersey as follows; the CFO and Administrator are authorized to complete the financial transactions associated with purchasing the above identified Truck and accessories for the Franklin Township Public Works Department, in the amount of \$126,796.00.
