**RESOLUTION AUTHORIZING THE ADMINISTRATOR TO ENTER INTO A  
CHANGE ORDER FOR THE REHABILITATION CONTRACT WITH JVA  
SERVICES LLC FOR REHABILITATION WORK ON THE FRANKLIN  
TOWNSHIP TRAIN STATION NOT TO EXCEED AN ADDITIONAL \$2,485.00**

**WHEREAS**, the Township desired to complete a rehabilitation project on the Franklin Township Train Station, including but not limited to repair of decking, steps and handicapped walkway; new replacement windows; exterior fiberglass door; and removals of old wood siding and replacement with vinyl board and batten style siding; and

**WHEREAS**, JVA Services LLC 207 Cherry Tree Court, Franklinville, NJ 08322 has submitted the lowest total bid for the above listed items, and was approved for the job under R-169-24; and

**WHEREAS**, JVA purchased all required materials and removed all old items and installed purchased replacement products on site but there was additional replacement and repair needed once rehabilitation started, additional products were purchased and installed for an amount not to exceed \$2,485.00 over and above the originally the quoted amount of \$36,870.01; and

**WHEREAS**, the CFO has certified the availability of the additional funds from account #T-18-56-850-805 titled Historic Property Preservation of the Open Space Trust Fund.

**NOW THEREFORE BE IT RESOLVED**, by the Mayor and Committee of the Township of Franklin, County of Gloucester, State of New Jersey as follows; the CFO and Administrator are authorized to complete the financial transactions associated with above mentioned rehabilitation contract at the Franklin Township Train Station.
