**RESOLUTION NO. R-190-2024**

**RESOLUTION AUTHORIZING THE TOWNSHIP ADMINISTRATOR AND  
DIRECTOR OF PUBLIC WORKS TO FINALIZE THE PURCHASE OF A SPARE  
SENIOR CITIZEN BUS FROM THE TOWNSHIP OF MANTUA FOR USE WITHIN  
THE TOWNSHIP OF FRANKLIN FOR THE SENIOR LUNCH PROGRAM OR OTHER  
ACTIVITES WHEN NEEDED**

**WHEREAS**, the Township of Franklin has a need for a spare senior citizen transportation bus; and

**WHEREAS**, the Township of Mantua has such a vehicle available for sale and the purchase was previously authorized under R-144-24; and

**WHEREAS**, in accordance with the Local Public Contracts Law and N.J.S.A. 40a:11-5(2) purchases from another New Jersey municipality do not require a quoting or public bidding process; and

**WHEREAS**, the Township of Mantua has accepted an offer for the vehicle; a 2001 Freightliner passenger bus, color white; VIN#:4UZAABBWB82CK01981 for the sum total amount of \$1,500 under their resolution R-119-24; and

**WHEREAS**, the CFO has certified the availability of funds from account #4-01-26-311-299 titled Community Center Miscellaneous.

**NOW, THEREFORE, BE IT RESOLVED** by the Township Council of the Township of Franklin, in the County of Gloucester, State of New Jersey, that the Township of Franklin is hereby authorized to purchase and add to the Fixed Asset Inventory the 2001 Freightliner and that payment is authorized to be made to the Township of Mantua in the amount of \$1,500 without a public bidding process pursuant to N.J.S.A. 40a:11-5(2).
