**RESOLUTION ACKNOWLEDGING AND DIRECTING TOWNSHIP
ADMINISTRATOR AND CFO TO COMPLETE AND SUBMIT ANY REQUIRED
DOCUMENTATION TO THE 2025 GLOUCESTER COUNTY CAPITAL TRANSIT
INVESTMENT PLAN (CTIP) FOR A NEW SENIOR PROGRAM
TRANSPORTATION BUS**

WHEREAS, the Township of Franklin (“Township”) has the need for funding to facilitate a purchase of a new bus for the Senior Transportation Program and;

WHEREAS, the Township of Franklin Administrator has previously applied to the Gloucester County CTIP program for a new Senior Program Bus; and

WHEREAS, based upon review of the submitted application, Franklin Township has been designated as a recipient and is eligible for up to \$50,000.00 in matching funds for the purchase of a new Senior Program Transportation Bus; (See Attachment) and;

WHEREAS, the purpose of the bus is in furtherance of the Townships provision of transportation services for the elderly, disabled transit dependent residents primarily and to the general public in the Township of Franklin’s established service area and program; and

WHEREAS, the CTIP requires the Township of Franklin and the County of Gloucester to enter into a Capital Transit Investment Plan Bus Purchase Agreement substantially in accordance with the terms and conditions set forth in the agreement; and

WHEREAS, the Township of Franklin’s utilization of CTIP requires the utilization of the bus for the purposes set forth and in accordance with the terms and conditions set forth in the agreement; and

NOW THEREFORE BE IT RESOLVED, by the Township Committee of the Township of Franklin, Gloucester County, New Jersey, that they acknowledge and approve the parameters of the above Gloucester County CTIP, and will utilize the award monies to make the purchase of a new Senior Program Transportation Bus; and do hereby authorize the Administrator and CFO to complete the aforementioned agreement after review by the Township appointed Solicitor.
