**RESOLUTION AUTHORIZING THE TOWNSHIP ADMINISTRATOR AND THE  
DIRECTOR / SUPERINTENDENT OF PUBLIC WORKS TO AMEND THE  
SUPERVISOR OF PUBLIC WORKS EMPLOYMENT AGREEMENT WITHIN THE  
DEPARTMENT OF PUBLIC WORKS TO NOW INCLUDE ALL PESTICIDE  
APPLICATIONS WITHIN THE TOWNSHIP**

**WHEREAS**, the Township of Franklin desires to continue excellent services to the residents of Franklin Township; and

**WHEREAS**, the Township Supervisor of Public Works has obtained his New Jersey Pesticide Applicators License while working through the Department of Public Works; and

**WHEREAS**, based on availability of funds (Acct#: T-18-56-850-804) as certified by the CFO; he will now be compensated a Stipend in the amount of \$5,000.00 per year; retroactive for 2025 to May 1<sup>st</sup>; and

**NOW, THEREFORE, BE IT RESOLVED**, by the Township Committee of the Township of Franklin, County of Gloucester, State of New Jersey that the Director / Superintendent and the Township Administrator both be and are hereby authorized to designate the amendment to the Supervisor of Public Works Jared Marandino’s employment agreement to include the stipend position of Pesticide Applicator.
