AUTHORIZING THE ADMINISTRATOR AND CFO TO BEGIN THE ACQUISITION PROCESS FOR THE PURCHASE OF FOUR (4) 2025 FORD POLICE INTERCEPTORS AWD VEHICLES FROM WINNER FORD THROUGH THE NJ CONTRACT #20-FLEET-01189 AND THE PURCHASE OF THREE (3) CHEVROLET MALIBU LS 1FL SEDANS FROM HERTRICH FLEET SERVICES, INC., THROUGH THE CRANFORD POLICE CO-OP#:47-CPCPS

WHEREAS, the Township of Franklin Police Department desires to purchase four (4) 2025 Ford Police Interceptor AWD Vehicles (\$172,572.00); along with three (3) Chevrolet Malibu LS Sedans (\$70,267.50); and

WHEREAS, the Township is a member of the State Contract purchasing agreement and the Cranford Police Co-op under the authority of N.J.S.A. 5:34-7: and

WHEREAS, Winner Ford has been awarded the contract for 2025 Ford Police Interceptor AWD Vehicles; along with Hertrich Ford who has been designated by the Cranford Police Co-OP; and

WHEREAS, All vehicles purchased will require some modifications and upfitting specific to each vehicle. Upfitting completed by **Winner Ford** (\$83, 245.32) will be under NJ Contract #: **Whelen** – 17-FLEET-00761; **Havis** – 17-FLEET-00719; **Progard** – 17-FLEET-00768. Upfitting to be completed by **Vineland Auto Electric** (\$11,809.47) – NJ Contract#: T0106. Lettering of three (3) patrol vehicles: **F&W Grafix** – (\$2,361.00); and

WHEREAS, the CFO has certified the availability of funds in the amount of \$337,894.29 which shall be charged against General Capital budget line-item No. C-04-25-010-003, entitled Police Vehicles & Equipment; and

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Committee of the Township of Franklin, County of Gloucester, State of New Jersey, that the contract for the purchase of four (4) 2025 Ford Police Interceptor AWD Vehicles is hereby awarded to Winner Ford, 250 Haddonfield – Berlin Road, Cherry Hill, NJ and the contract to purchase three (3) Chevrolet Malibu LS is awarded to Hertrich Ford 1427 Bay Road, Milford, NJ 19963. Individual upfitting of each vehicle is awarded as described above.

BE IT FURTHER RESOLVED that the Administrator and the CFO are authorized to execute all documents required to effectuate this contract.
