**WHEREAS**, 26.25% of the total appropriations in the 2016 budget exclusive of any appropriation made for Debt Service, Public Assistance or Capital Improvement Fund in the said 2015 budget is the sum of \$2,162,779.24 and;

**WHEREAS**, the New Jersey Statutes 40:4-19 provides that temporary appropriations should be made for the amount of such Debt Service in the manner and time therein provided; and

**NOW THEREFORE BE IT RESOLVED**, that the following temporary appropriations be made, and that a certified copy of this resolution be transmitted to the Chief Financial Officer for her records.
