

**RESOLUTION
TOWNSHIP OF FRANKLIN
APPOINTING A CONFLICT SOLICITOR FOR THE TOWNSHIP OF FRANKLIN
FOR THE YEAR 2015, PURSUANT TO THE LOCAL PUBLIC CONTRACTS
LAW (N.J.S.A. 40A:11-1, ET SEQ.)
R - 17 - 2015**

WHEREAS, there exists a need for a Conflict Solicitor in the Township of Franklin to serve in the event of a conflict of interest arising with the appointed Solicitor for the purposes of providing the Township Committee of said Township with legal counsel and advise; and

WHEREAS, pursuant to the provisions of N.J.S.A. 19:44A-20.5, the Township Committee has determined to award said contract as a fair and open contract; and

WHEREAS, funds are or will be available for this purpose; and

WHEREAS, the Local Public Contracts Law (N.J.S.A. 40A:11-1 et seq.) requires the governing body of a contracting unit to publish a notice in a newspaper authorized by law to publish its legal advertisements, setting forth the nature, duration, service and amount of the contract where such contract is awarded for "professional services".

NOW THEREFORE, BE IT RESOLVED, by the Township Committee of the Township of Franklin, County of Gloucester, State of New Jersey, as follows:

1. That DOUGLAS LONG, ESQ. and the Law Firm of LONG MAMERO & ASSOCIATES, 44 Euclid Street, Woodbury, New Jersey 08096, and JOHN A. ALICE, 28 Cooper Street, Woodbury, New Jersey 08096 are hereby retained as Conflict Solicitor for the Township of Franklin, to provide counsel, advice and legal services to the officials of said Township for the year 2015.

2. The appropriate officers of the Township of Franklin are hereby authorized to enter into the contract with DOUGLAS LONG, ESQ. and the Law Firm of LONG MAMERO & ASSOCIATES, 44 Euclid Street, Woodbury, New Jersey 08096, and JOHN A. ALICE, 28 Cooper Street, Woodbury, New Jersey 08096 for the legal services above specified, for a term of one year as attached hereto for the year 2015.

3. The contract is awarded as a "professional service" under the provision of the Local Public Contracts Law because of the specialized training, education, experience and specialized knowledge needed for this position and pursuant to a "fair and open" process as provided in N.J.S.A. 19:44A-20.4 et seq.

4. A notice of the award of this contract shall forthwith be printed once in The Sentinel of Gloucester County, an official newspaper of the Township of Franklin, authorized by law to publish the legal advertisements of the Township Committee of the Township of Franklin, setting forth the nature, duration, service and amount of the contract, and further stating that this resolution and the annexed contract are on file and available for public inspection in the Office of the Clerk of the Township of Franklin.
